5. **PUBLIC HEARING PURSUANT TO SECTION 466-C OF THE REAL PROPERTY TAX LAW OF THE STATE OF NEW YORK TO CONSIDER ADOPTION BY THE BOARD OF TRUSTEES OF A RESOLUTION GRANTING A PARTIAL REAL PROPERTY TAX EXEMPTION FROM VILLAGE TAXES FOR MEMBERS OF ATLANTIC BEACH RESCUE AND/OR THE LONG BEACH FIRE DEPARTMENT AND ELECTED OFFICIALS OF THE ATLANTIC BEACH FIRE DISTRICT WHO ARE OTHERWISE OBLIGED BY LAW TO PAY SUCH TAXES**

WHEREAS, pursuant to section 466-C of the Real Property Tax Law of the State of New York, the Board of Trustees of the Village of Atlantic Beach is authorized to hold a public hearing to consider adopting a resolution granting a partial real property tax exemption from Village taxes for authorized volunteer firefighter and volunteer ambulance service members who are Village residents and otherwise obliged by law to pay such tax, on terms set forth therein: and

WHEREAS, the Village of Atlantic Beach is interested in availing itself of that authority, including but not limited to consideration of a resolution authorizing such partial tax exemption for residents of the Village who are members of Atlantic Beach Rescue and/or the Long Beach Fire Department, or elected officials of the Atlantic Beach Fire District, who are otherwise obliged by law to pay Village taxes.
